FEDERAL	Salmon, whitefish, sheefish, or any other fish taken from <u>federally managed waters in Alaska</u> (See map of federal public lands on back)	YES	YES cannot be sold to a commercial enterprise.
STATE	Salmon, whitefish, sheefish, or any other fish taken elsewhere in the Kotzebue District	YES	NO
STATE	Salmon or sheefish taken during a commercial fishery with a commercial fishing permit	YES	YES
MARINE MAMMALS			
FEDERAL	Nigipiaq from marine mammals, such as seal oil, muktuk, black meat, etc. CITATION: 16 U.S.C. § 1371 " ...And provided further, That any edible portion of marine mammals may be sold in native villages and towns in Alaska or for native consumption..." 50 CFR § 18.23 (b)(2) ...no marine mammal taken...may be sold or otherwise transferred to any person other than an Indian, Aleut, or Eskimo...unless: ...(iv) It is an edible portion and it is sold (A) in an Alaska Native village or town or (B) to an Alaska Native for his consumption. FEDERAL	Moose, bear, sheep, and all wildlife other than hare (see above) AUTHORITY: Alaska Hunting Regulations 5 AAC 92.200	YES cannot barter with a business for commercially sold goods or services	NO
